# 2020 Financial Report/2021 Operating Budget Doylestown Presbyterian Church Financial Forward

#### 2020 Financials

We have completed the first twelve months of our Embark initiative, where our members made pledges to cover all operational costs, including our monthly mortgage payments. Any funds received in excess of budget at the conclusion of the 2-year initiative (end of 2021) will be applied to the outstanding balance of the renovation loan. The campaign total was \$3,829,524, the highest multi-year pledge in our congregation's history. After adjusting for designated gifts, self-declared one year-only-pledges and using our historic average of 3% shrinkage between pledges and the actual amount received, we expected to receive gifts totaling \$1,891,038 for 2020. As of December 31, 2020, we had pledge receipts to the Operating Fund of \$1,882,001, slightly under our budgeted pledge total. Our non-pledge giving exceeded expectations, totaling \$136,381, which contrasts positively to a budgeted amount of \$127,000. Despite a global pandemic (COVID-19) and the fact that we have been able to hold only one in-person worship in our sanctuary since March of 2020, our members have remained faithful and dedicated to our body of faith.

In addition, we participated in the Payroll Protection Plan offered by the federal government, receiving a loan in the amount of \$146,475 to ensure that we were able to pay our staff and bills. At the end of the year, we received notice that this loan had been forgiven. All of these gifts have allowed us to end the year with a net income of \$420,536. This net income will allow us in 2021 to continue supporting our ministries fully and have resources available for additional loan principal payments.

This year, DPC was able to provide over \$200,000 of support to organizations helping neighbors most in need in our community and around the world. Highlights of our mission work this year included helping a woman get back into her Jersey Shore home 8 years after Hurricane Sandy made it uninhabitable; aiding Broad Street Ministry with their COVID response in the face of explosive need, particularly after their storage pod was destroyed; and addressing growing hunger needs elsewhere, including in the Southwest Native American communities served by our partners Americans for Native Americans and the Community Pantry. In total, our congregation has supported nearly 30 organizations this year, serving as a "bridge for Christ and a beacon of His love" to those struggling amongst us.

#### 2021 Budget

Our expected pledge receipts for 2021 was determined by taking into consideration changes in pledges, designated gifts and our historic average of 3% shrinkage between pledges and the actual amount received. We set a conservative non-pledge income figure based on what those gifts have been historically and the amount received in 2020. Thus, the 2021 budget has a target for total income of \$1,980,905. We continue to include our monthly mortgage to First National Bank of Newtown and have additional money set aside for loan payments and building emergencies. The Personnel budget for 2021 is higher than the previous year's actual expenses partly due to including a full year of our Maintenance Engineer (moved from the facilities budget where it had resided in recent years) and a partial year of an Interim Director of Teens and Tweens. The budget includes funds for our next stewardship initiative that will occur in the fall of 2021. The mission percentage for the new budget remains the same at 10% of all undesignated gifts.
